- The Government of Nepal [GoN] has allocated funds or received a loan/credit/grant from [GoN or Development Partner] towards the cost of Construction of Kolhabi Open Market (Haat Bazzar) at Kolhabi, Ward no. 1 and intends to apply part of the funds to cover eligible payments under the Contract for Construction of Kolhabi Open Market (Haat Bazzar) at Kolhabi, Ward no. 1 (Contract No.: KM/NCB/BLDG/02/2078-2079). Bidding is open to all eligible as per Section V of bidding document..
- 2. **KOLHABI MUNICIPALITY, BARA** invites electronic bids from eligible bidders for the construction of Construction of Kolhabi Open Market (Haat Bazzar) at Kolhabi, Ward no. 1 under National Competitive Bidding Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs. 140,200,000.00
- Minimum Work experience of similar size and nature: NRs. 112,100,000.00
- 3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

- 6. Pre-bid meeting shall be not be held.
- 7. Electronic bids must be submitted to through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 03/05/2022 12:00. Bids received after this deadline will be rejected.
- 8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 03/05/2022 13:00 at the office of Office of Municipal Executive, Kolhabi Municipality, Kolhabi-1, Bara, Province no. 2, Nepal. Bids must be valid for a period of 120 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid,\amounting to a minimum of NRs. 4,700,000.00, which shall be valid for 30 days beyond the validity period of the bid (i.e. 30/09/2022)
- 9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
